# Republican Party of Virginia 2024 Quadrennial Convention May 31-June 1, 2024 Hampton Roads Convention Center 1610 Coliseum Dr Hampton VA 23666 (Convening on 05/31 at 2:30 pm and on 06/30 at 10:00 am)

## **Call to Convention**

As Chairman of the Republican Party of Virginia and pursuant to the Plan of Organization ("Plan") and as recommended and directed by the State Central Committee, I, Rich Anderson, do hereby issue this Call for a the Republican Party of Virginia's 2024 Quadrennial Convention (the "Convention") to be held at the Hampton Roads Convention Center on May 31 and June 1, 2024 for the following purposes:

- Selecting two Electors At-Large to be voted for in the presidential election on November 5, 2024;
- Electing a State Chairman;
- Nominating a National Committeeman and National Committeewoman;
- and for the transaction of such other business as may properly come before the Convention.

The Convention will open on May 31 at 2:30 pm for the election of permanent Convention officers and adoption of rules. No other election shall occur prior to 10:00 am on June 1.

I further direct the Executive Director of the Republican Party of Virginia to publish this Official Call on the Party's website and via such other means as may be necessary, in accordance with Republican National Committee Rules. I further direct the Congressional District Chairmen to call and make all necessary arrangements for Congressional District Conventions for the purpose of selecting an Elector to be voted for in the presidential election on November 5, 2024; electing a District Chairman; electing three members to the State Central Committee; and for the transaction of such other business that may properly come before the District Convention; and I further direct the Congressional District Chairmen to issue the call for each District Convention to each unit chairman within the district no later than February 1, 2024, for District Conventions to be held no earlier than March 1, 2024, and no later than May 26, 2024, and to publish such call in accordance with the Republican Party of Virginia's Plan of Organization

### **Qualifications for Participation**

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required their intent to support all of its nominees for public office in the ensuing election may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

# **Composition of Convention**

The Convention shall be composed of delegates and alternate delegates of the respective units they represent. Representation shall be based on the total number of Republican votes cast in each county and city in the last gubernatorial and presidential elections combined. Each unit delegation's voting strength shall equal one (1) Delegate Vote for each two hundred fifty (250) votes cast or major portion thereof for the Republican candidate in the most recent elections for President and Governor. Each unit shall be entitled to at least one (1) Delegate Vote. Each unit's maximum number of delegates is a number five (5) times its respective Delegate Vote. Each locality's Delegate Vote is set forth below:

## **Election and Selection of State Convention Delegates**

The delegates and alternates shall be elected at county and city mass meetings, canvasses, or conventions called by each unit for the purpose of electing delegates to their respective Quadrennial Congressional District Conventions. The election of delegates and alternates to the state Convention shall take place no earlier than February 5, 2024, and no later than April 15, 2024. The deadline for prefiling as a candidate for Convention delegate shall not be earlier than February 1, 2024.

## Military Member Provisions

Any Military Member who is otherwise qualified under Article I to participate in Republican Party actions and who complies with the procedures set forth in the Official Call of their Unit Mass Meeting, Convention, or Party Canvass and who produce valid military identification or other proof of active-duty status shall be certified as a delegate and shall not be required to be elected as a delegate. Delegates certified in this manner shall count towards each unit's maximum number of delegates.

Military Member Delegates who are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Candidate preference ballots shall list the Military Member's rank order preference among candidates. Their votes shall be cast for the highest ranked choice candidate who remains eligible to receive a vote in a particular round of voting.

Candidate preference ballots shall be made available on the RPV website no later than May 11, 2024, and must be returned to military-ballot@virginia.gop no later than May 28, 2024. The Chairman shall cause the ballots received to be certified to the credentials committee to be tabulated with each unit's votes.

#### **Registration Fee**

Delegates shall pay a registration fee of forty-five (45) dollars.

#### **Pre-Filing**

Delegate candidates required to submit pre-files may, if authorized in their respective unit's official call, do so, centrally via the RPV Chairman. Such filings may be accomplished electronically at www.Virginia.GOP, or they may complete the hardcopy pre-file form (attached hereto) and remit with any filing fee payment to the Chairman via postal mail. Whether filed electronically or via postal mail, all delegate candidate filings must be received by the date specified in the official call for the mass meeting, convention or canvass, at which the delegate candidate is standing for election. Postmarks do not govern. The Executive Director is instructed to take all necessary steps to accommodate Congressional District Committees that issue calls for their respective conventions authorizing delegate candidate pre-filing to be conducted via the Republican Party of Virginia in the same manner as set forth herein for candidates for state Convention delegate.

Unit and District chairmen shall automatically receive copies of electronic pre-files from their respective election districts received by RPV. Complete official lists of pre-files for use by the respective credentials committees (each a "Pre-File Certification") will be forwarded by the Executive Director to all of the respective unit chairmen and District chairmen no later than 3 days after the deadline for submitting pre-filings.

# **Candidates for Offices Filled by the Convention**

State Party Chairman, National Committeeman, and National Committeewoman

Candidates for Republican Party of Virginia State Chairman must submit a completed original version of the relevant filing form along with a check or proof of electronic payment of a filing fee to the Republican Party of Virginia, to the Chairman via postal mail, or in person, to be received no later than 5:00 PM January 15, 2024. Postmarks do not govern. The filing fee for State Chairman is \$6,000; the filing fee for National Committeeman and National Committeewoman is \$3,000.

#### Elector

Candidates for Elector At-Large must submit a completed original version of the official filing form, along with a check or proof of electronic payment of a \$450 filing fee to the Republican Party of Virginia, to the Chairman via postal mail to be received no later than 5:00 PM April 12, 2024. Postmarks do not govern.

# **Certification of Delegates**

Delegates and alternate delegates elected by each unit shall be certified in accordance with the Plan. Certifications shall be made using a form to be posted on the RPV website, and must be delivered to the Chairman or his designee no later than May 15, 2024, postmarked by mail, or May 17, 2024, if delivered electronically or in person. Certifications should be delivered as soon as possible after the election of delegates or, in the case of a cancelled Mass Meeting, Party Canvass, or Convention, the declaration of their election.
